Staff will still be required to wear face coverings in communal areas. This will commence from Monday 17<sup>th</sup> May.</li> <li>• I will also be advising parents that students will no longer be required to tie long hair back.</li> <li>• Rapid testing using Lateral Flow Devices (LFD)s will support the return to face-to-face education by helping to identify people who are infectious but do not have any coronavirus (COVID-19) symptoms.</li> <li>• Staff and pupils will move to a home testing model (for pupils, following the first 3 onsite tests). The lateral flow devices used have received regulatory approval from the MHRA for self-use.
